## **2. Your consent**

The fact:

### **3. Collection and processing of the information gathered by Xcash Money Solutions**

#### **a) Collection**

No personal information about you is gathered upon your simple access or browsing on this website. But, it must be noted that as soon as you access Xcash Money Solutions website, some information is gathered automatically by our computer system.

None of this information allows Xcash Money Solutions to identify you. It includes information about your domain name as well as the IP address through which you access this website. Such information may be used by Xcash Money Solutions for statistical purposes. For example, to check and analyze the access frequency to its website and related customer base.

Your personal information is gathered only when and if you voluntarily provide them to Xcash Money Solutions, including in the course of your participation to any service offered by Xcash Money Solutions, which requires you to provide such information, subject to any objection expressed on your part.

In all cases where you voluntarily provide personal information to Xcash Money Solutions, it undertakes to collect, use and/or communicate it under this policy and applicable legislation.

Xcash Money Solutions commits to never disclose any of the personal information it gathers to third parties. We keep everything confidential. We disclose information only if we get your consent and in certain exceptional circumstances where the law requires it.

The permission from a parent or a tutor is required for anyone under the age of 18 years old to take part in any activity organized by Xcash Money Solutions (like a survey, contest or promotion).

Xcash Money Solutions will not collect nor use any personal information relating to Minors without the consent of a parent or tutor.

## **7. Usage of cookies**

Usage of cookies is not linked to any identifiable information. You may at all time deactivate cookies by modifying the configuration of your browser. Doing so may restrict you from accessing some parts of our website.
